Introduction

Collection of Information

In order to use the Data Revival services, we may require information from you in order to provide the best service possible.

Use of Collected Information

Storage of Collected Information

The security of your personal information is important to us. You will enter sensitive information (such as credit card numbers) only on our Internet payment gateway provider eWay website, where information is encrypted using secure socket layer technology (SSL). When Credit Card details are collected, we simply pass them on in order to be processed as required. We never permanently store complete Credit Card details.

We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it
